Linux Software Solutions for IBM Power Systems First-in-Location rebate offering

Effective January 3, 2017, IBM is announcing the Linux Software Solutions for IBM Power Systems First-in-Location rebate offering.

Value proposition

This offer can be used as an incentive to purchase a PowerSystems server to run the selected LinuxISV Software or add a net newLinux ISV software module.

The offer

You can receive a rebate if you acquire a solution that consists of:

- one or more selected eligible new* IBM Power Systems servers; and
- one or more eligible new Linux Independent Software Vendor (ISV)software applications, and/or software modules, from the same ISV.

To qualify for the Linux ISV rebate, you must meet one of the requirements below

- The Linux ISV software application(s) and/or software modules must represent a first-in-location acquisition of the eligible new Linux software application and/or software module from the ISV, and be planned for installation and execution on the eligible new IBM Power Systems server(s) acquired as part of the solution.
 - In order to qualify as first-in-location, no other licenses for the eligible new Linux software application and/or software module sold by the ISV may have been installed, at any time, in your customer location (single building with a single mailing address) on any IBM Power Systems server, or
- Acquire one or more selected eligible new Power Systems servers andmigrate a qualifying
 existing Linux ISV software application from a non-IBM platform to the eligible new IBM Power
 Systems server andacquirequalifying new Linux ISV software application and/or module as part
 of the solution.

The amount of the rebate will be equal to the total invoice price of the eligible new Linux ISV initial license fee and/or 1-year subscription fee per software application(s) and/or software module(s)acquiredup to a maximum rebate of 5% of the list price of the eligible new Power Systems server acquired.

There is a limit of one rebate per solution, which includes all components: the eligible new machine serial number(s) acquired, and the eligible new Linux ISV software license(s) acquired. Once included in a solution, components cannot be included in another solution.

Start and/or end dates

There must be no more than six months between the invoice date and/or lease commencement date of the first and last components acquired as a part of a solution.

Terms and Conditions

Eligible Linux ISV software must appear on the list of eligible new Linux ISV software applications/modules in effect on the date of the invoice for the eligible Linux ISV software.

For hardware purchase transactions:

- Power server(s)must appear on the list of eligible new Power Systems servers in effect on the date of the IBM invoice for the eligible Power Systems server, and
- IBM invoices for eligible Power servers must have a date that is on or after the date of the invoice for the first eligible new Linux ISV software license acquired as part of the solution.

For hardware lease transactions:

- Power servers must appear on the list of eligible new Power Systems servers in effect on the date of the signed and accepted Leasing Certificate of Acceptance, or lease contract with "Deemed Acceptance", for the eligible Power Systems server, and
- The signed and accepted Leasing Certificate of Acceptance, or lease contract with "Deemed Acceptance", for the eligible Power Systems server must have a commencement date that is on or after the date of the invoice for the first eligible new Linux ISV software license acquired as part of the solution.

Rebate request forms must be received by IBM no later than two (2) months after the invoice date or lease commencement date of the last new component acquired as part of a solution.
